Thank you for the invitation to the Scottish Human Rights Commission (SHRC) to attend the SPCB Supported Bodies Landscape Review Committee on 27th February 2025 to give evidence to inform the Inquiry's recommendations.

I hope you and the Committee members agree that the wide ranging discussion on the function, performance and current remit of the SHRC was useful, and that it was a positive opportunity to engage the Committee on broader issues of mandate, comparative and future opportunities for ensuring rights realisation for all in Scotland, and the role of the SPCB in supporting officeholders.

During that meeting, I was asked a series of direct questions about the SHRC's position on women's rights by Ash Regan MSP.
